Its purpose is to provide financial assistance to young Jewish men and women students graduating from Atlantic County and Cape May County high schools.

Applicants must be Jewish with high scholastic achievements, be active in Jewish affairs as well as school and community affairs, and have need of financial assistance. Each year a four year commitment is made to next year's recipients. Awardees must maintain high marks not less than a 3.0 GPA, participate in extracurricular activities and not reflect adversely on themselves or AVODA.

This application and your official high school transcript through the first half of the current school year including grades and SAT scores must be received by March 2, 2018.

How the process works is as follows:

- Your Guidance Counselor will give you a hard copy of the award application to complete.
- The application instructs you to then access the JCC website <u>www.jccatlantic.org</u>.
- There you will find a link to AVODA and the on-line questionnaire to complete. Download the application to generate a form that can be filled out on-line.
- You can simply fill it out on-line, print it, and submit it. Only the on-line version of the application is acceptable.

Be assured that this application and its contents will be carefully guarded and destroyed once the AVODA committee makes its decision.
